

UYAHOGA COUNTY JUVENILE COURT IS THE SECOND OLDEST COURT OF ITS KIND IN THE COUNTRY. SINCE ITS INCEPTION IN 1902, THE JUDGES, STAFF, AND VOLUNTEERS OF THE COURT HAVE WORKED TOGETHER TO PROVIDE QUALITY SERVICES TO COURT-RELATED YOUTH AND FAMILIES AND TO PROTECT THE INTERESTS OF THE COMMUNITY. THE MISSION OF THE COURT CONTINUES TO BE TO PROVIDE ITS SERVICES IN THE MOST EFFECTIVE AND EFFICIENT WAY POSSIBLE.

Cuyahoga County Juvenile Court is the largest Juvenile Court in the State with over 550 employees, an annual budget of \$17.89 million, and over 20,000 filings yearly. The Court has jurisdiction over a variety of juvenile and adult cases including juvenile traffic, delinquency, unruly, dependency, neglect, abuse, and parent-child relation.

Five judges and eight referees hear all of the official complaints that come before the Court. An Administrator oversees nine divisions of the Court that provide a wide range of legal, social, residential, and community services. Ohio law requires juvenile courts to effectuate the following purposes.

- Provide for the care, protection, and mental and physical development of children subject to its jurisdiction;
- Protect the public interest in removing the consequences of criminal behavior and the taint of criminality from children committing delinquent acts and to substitute therefor a program of supervision, care, and rehabilitation;
- Achieve the foregoing purposes, whenever possible, in a family environment, separating the child from its parents only when necessary for his welfare or in the interest of public safety;
- Provide judicial procedures through which Chapter 2151 of the Revised Code is executed and enforced, and in which the parties are assured of a fair hearing, and their constitutional and other legal rights are recognized and enforced. 2151 O.R.C.

In 1984, Cuyahoga County Juvenile Court established goals that reflect the guidelines defined by Ohio law. The following information highlights some of the accomplishments of the Court that contributed to the achievement of these goals.

GOAL I: The Court shall encourage development of local and state youth service programs that have maximum impact in promoting youth development and preventing delinquency.

Thirty-six local programs that provide alternatives to secure detention and assist in preventing youth from entering into contact with the juvenile justice system were funded by the Court and county administration with the State Subsidy. A cross-section of programs were funded so that the varied needs of youth could be addressed. The services provided include education, employment, substance abuse, sheltercare, and counseling.

GOAL II: The Court shall maintain adequate detention resources to serve Cuyahoga County.

The quality of the Detention Center services was improved through the establishment of a behavior management program and specialized educational classes. Expanded visiting hours, additional volunteer programs and a speakers series that featured community

leaders contributed to the community and parental involvement in the Detention Center program. Alternatives to Detention Center placements were continued and expanded through the use of sheltercare and the Home Detention Program.

GOAL III: The Court shall encourage the development and maximum appropriate utilization of private residential and non-residential services for Court-involved youth.

The new case assignment procedure for supervisory probation officers allows for more frequent school visits, increased familiarity with the neighborhoods, and an improved relationship with the youth. Specialized alcoholism training for court staff was offered so that quality services could be offered to the large number of youth that are chemically dependent. The Court also increased its ability, by fifty percent, to quickly transport youth to facilities around the county and state.

GOAL IV: The Court shall provide services designed to decrease the likelihood that young people will become involved with the criminal justice system after they become adults.


The Court and Ohio Department of Youth Services started the Serious Offender Project that offers detailed assessment, institutionalization, group home placement, and intensive community services. The program should prove to be a less costly and more effective method of preventing future criminal activity. Tutoring programs by court volunteers and job training and placement helped to give youth the skills necessary to become productive members of society.

GOAL V: The Court shall provide information on its operation and goals to the public, agencies, and parties coming before the Court.

Over two hundred presentations on the purpose and operation of Juvenile Court were given to schools, agencies, and community groups. Staff and the judges testified before special task forces of the Ohio Legislature on issues related to the Juvenile Court. In addition, over one thousand adults toured the Detention Center or observed court hearings.

GOAL VI: The Court shall operate its programs as part of the larger youth service and juvenile justice system.


The Court increased its efforts to work jointly with the schools, police, youth service agencies, and community organizations. The Court contributed to the Cleveland Schools' Youth Resource Centers where services were offered to improve student attendance, behavior and achievement. Staff and the judges were recruited for and participated on innumerable committees and boards of organizations that address the problems of youth and the community.

UYAHOGA COUNTY JUVENILE COURT IS A SEPARATE DIVISION OF THE COURT OF COMMON PLEAS. THE FIVE JUDGES OF THE COURT ARE ELECTED COUNTY WIDE TO SIX-YEAR TERMS. THE ADMINISTRATIVE JUDGE WORKS WITH THE ADMINISTRATOR TO MANAGE COURT OPERATIONS. THE ADMINISTRATOR IS SUPPORTED BY NINE DIVISIONS.



LEGAL DEPARTMENT:

The major purposes of the Legal Department are to keep informed of the rapid changes in juvenile law and to insure the Court's compliance with these legal mandates. The Legal Director and Assistant Legal Director achieve these goals with the assistance of the following units.

- The INTAKE and RECEIVING OFFICE interviews all persons wishing to file a complaint with respect to a child or an adult and determines whether the Court will accept jurisdiction of the matter.
- The ASSIGNMENT OFFICE schedules a court date, assigns a probation officer if the complaint alleges delinquency or unruliness and prepares all necessary notices, summonses and subpoenas.
- REFEREES hear complaints that allege unruliness or a relatively minor delinquency offense.
- The CLERK'S OFFICE maintains case files, the appearance docket, and the Court's journal. Motions and applications filed by parties or their attorneys, preparation of cases for appeal, service by certified mail or publication, and the processing of comprehensive reunification plans are also handled by this unit.
- The TRAFFIC OFFICE hears all traffic cases, maintains records on these cases and communicates to the Ohio Bureau of Motor Vehicles concerning these cases.
- The ASSIGNED COUNSEL OFFICE appoints attorneys to act as legal counsel and / or guardian ad litem for qualified parties.
- The EXPUNGEMENT OFFICE pursues the neccessary steps to expunge or seal juvenile records.

PROBATION DEPARTMENT:

The major purposes of the Probation Department are to provide social and psychological information to assist in making appropriate dispositional decisions and to provide services that rehabilitate adjudicated youth. The following divisions exist to accomplish these activities.

- PROBATION OFFICERS either prepare and present pre-hearing case records on persons charged with various law violations or provide counseling to youngsters as ordered by the judges.
- The RECORD ROOM maintains the social records and other documents related to case records.
- PLACEMENT SERVICES schedule and arrange boarding school placements for children who have been declared delinquent or unruly and ordered by the Court to be removed from their homes. Also, contact is maintained by the Court with the representatives of the different institutions, the youngsters and their families.
- VICTIM AID SERVICES provides relief to those

- persons who have sustained physical, psychological, or material injury at the hands of youthful offenders.
- The CUSTODY REVIEW UNIT reviews Comprehensive Reunification Plans and the annual plan for services for children that are in the temporary or permanent custody of public or private agencies.

DETENTION CENTER:


The major purpose of the Detention Center is to provide youth with the needed supervision prior to a Court hearing on a delinquency or unruly filing and while awaiting placement at or commitment to a residential facility.

- The DETENTION CENTER provides a short-term custody service. A large multi-purpose staff treat the "whole" child by offering supervision, food, shelter, clothing, education, counseling, medical services, recreation, diagnostic services, and religious programming.
- EMERGENCY SHELTER CARE is available to youth who require supervision, but a less secure environment than that at the Detention Center.
- HOME DETENTION provides daily supervision to low risk children who return home pending a hearing in a "house arrest" status.


CHILD SUPPORT DEPARTMENT:

The major purposes of the Child Support Department are to enforce the support obligations owed by absent parents to their children and to establish the parent-child relationship (paternity). The units that achieve these goals are as follows.

- The INTAKE UNIT receives all cases.
- The CLERK'S OFFICE stores all legal files for child support cases, processes all legal documents, maintains an appearance docket and official court journal, and coordinates warrants, bail bonds and jail releases.
- REFEREES hear parent-child relationship cases and other child support matters.
- VISITING JUDGES from other Ohio counties hear enforcement actions (Motion to Show Cause or Complaint for Violation) that have been prepared by counselors in the enforcement unit and filed by the Cuyahoga County Prosecutor's Office.
- ENFORCEMENT is responsible for monitoring nearly 12,000 cases in which court orders have been made for child support payments through Juvenile Court.
- CASHIERS OFFICE maintains records which are readily accessible to Child Support Department personnel.
- The DATA ENTRY UNIT is responsible for entering all child support cases into the Juvenile Court Information System (JCIS), generating service of process to necessary parties and verifying service prior to court hearings.






^{**} Separate Arraignment Hearings are not scheduled for unruly cases and for children in the Detention Center.




