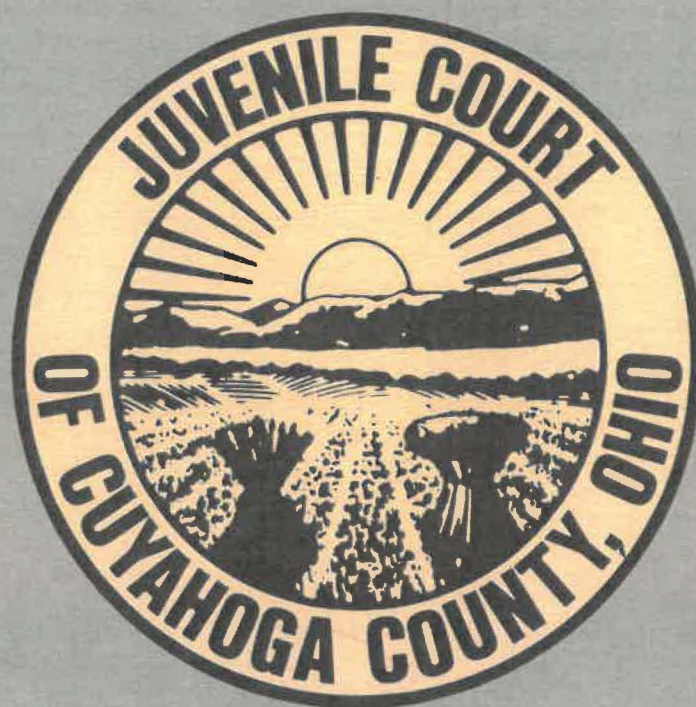

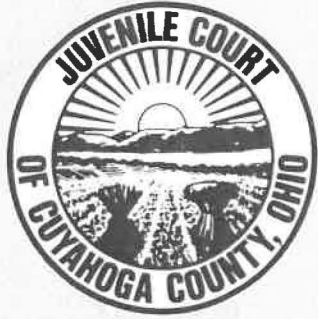

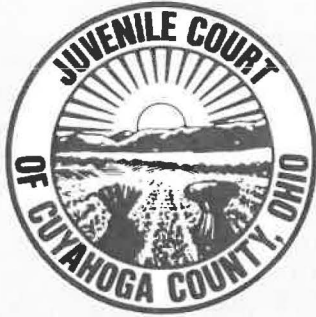

1. Open Letter

TO: The Citizens of Cuyahoga County

The Honorable Mary Boyle, Timothy Hagan, and Lee Wiengart

In 1994, the two-year downward trend in the total number of cases coming to the attention of the Court reversed. An increase of 8.6% was realized as the number of cases increased from 35,110 in 1993 to 38,118 in 1994. However, the number of delinquency complaints increased to a record high number of 12,970, reflecting an increase of 12% over 1993 and a 32% increase over 1989. The number of dependency, neglect, and abuse cases declined 13.4% in 1994 from 1993, but is 66% higher than five years ago (1989).

Overcrowding in juvenile correctional facilities is a national problem. Ohio is no exception. State operated juvenile correctional facilities have experienced increased overcrowding over the past ten years. As a result, the State of Ohio conceived RECLAIM OHIO to reduce the number of juveniles committed to Ohio Department of Youth Services (ODYS). This initiative, commencing for Cuyahoga County on January 1, 1995, allocates funds to counties based on the number of felonies adjudicated by the juvenile court. These funds may be used to pay for juvenile commitments to state operated facilities or to develop alternatives to commitment. Each juvenile committed to ODYS will cost the county \$76.75 per day (recently changed to \$79.65). For those committed for aggravated murder, murder, or rape there will be no charge to the Court. Cuyahoga County Juvenile Court will receive seventeen million dollars from this fund in 1995. Over the past year, the Court has developed Care and Custody Programs which are a range of alternative programs designed to reduce the number of commitments. The target populations are juveniles committed to ODYS and those in ODYS institutions considered appropriate for early release. To be funded are the Boot Camp, Community Corrections, a female offender program, a wrap-around service, a mentoring program, and sheltercare.

Increases in the number of delinquency cases affect all operations of the Court. Subsequent case processing delays dramatically affect the Court's Detention Center population. The Detention Center has a rated capacity of 86. In 1994, the average daily population was 144.7, 68% over the rated capacity and a 4.3% increase over the 1993 population of 138.7. According to a 1994 cost

analysis of the Court, the per diem cost of detention is \$142.98. Safety issues for staff and residents are a major concern as demonstrated by the 139% increase of official delinquency and unruly complaints filed against Detention Center residents in 1994. Despite the County budget crisis, the Court and County Commissioners still consider it essential to proceed with the construction of a new Juvenile Justice Complex.

This year a Case Management System was put into effect reducing the time between case filing and final disposition of the case. A 1990 study revealed delinquency cases were being disposed of at the rate of 30% within 200 days. The new system based on a mid-1994 study found delinquency cases reaching disposition at the rate of 79% within 67 days. Moving cases quickly through the Court system provides for a prompt outcome for the juvenile, family, and victim while reducing the strain on the Court and specifically detention services.

To demonstrate the Court's desire to provide excellent service for clients, Court departments were involved with two American Correctional Association (ACA) accreditations. The Detention Center, despite overcrowding and archaic design, received ACA accreditation in January 1994, after complying with all mandatory standards concerning health, safety and fire and 95% of the non-mandatory standards. The Probation Department was also accredited. This is its second reaccreditation by ACA after a three day audit, conducted in November 1994 by three ACA trained experts in the field of probation. With an exceptional performance, the Department complied with 99.3% of the 228 nationally accepted standards. On behalf of all the Judges, I extend appreciation to the Court staff and especially to the staff of Detention Services and Probation for making these accreditations possible.

In an effort to improve Court operations, three nationally recognized consultants were hired to provide recommendations concerning the areas of probation, case management, and the continuum of detention services. Committees have been established to review recommendations and make suggestions concerning implementation.

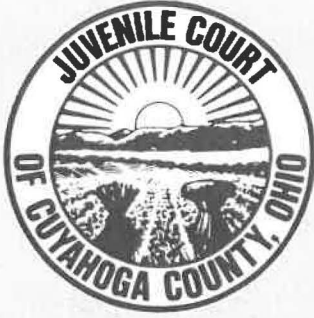
In conclusion I wish to acknowledge the accomplishments and endeavors of Judge Leodis Harris. During Judge Harris's five year tenure as Administrative Judge and eighteen year career as a Juvenile Court Judge, he brought the issues of Detention Center overcrowding to public view, created a boot camp style program as an alternative to commitment of juveniles to overcrowded state operated institutions, and established an unruly diversion program. Judge Harris's dedication, efforts and enthusiasm will long remain embedded in both the history and future of the Cuyahoga County Juvenile Court.

In compliance with Ohio Revised Code Section 2151.18, I submit the 1994 Annual Report of the Cuyahoga County Juvenile Court, which displays the number and kinds of cases, the dispositions, and other data pertaining to the work of the Court.

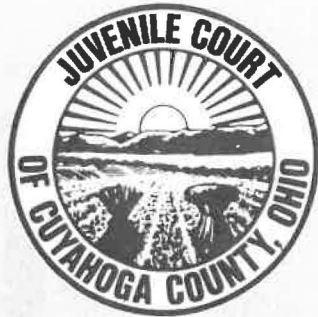
