In 1995, the Cuyahoga County Juvenile Court experienced a rise in cases, an 11% budget cut, a mandate to reduce commitments to state correctional facilities, and an overcrowded detention facility. In spite of these demands, the Court moved forward and created a Custody Mediation Project, opened a Day Treatment Center, and was the focus of a Cleveland Bar Association initiative on juvenile justice.

The upward trend in juvenile court cases continued in 1995. Total cases increased 3.5% over 1994, 21% over 1990, and 38% over 1985. Delinquency cases rose 5.2% from the previous year, 28% over 1990, and 142% over 1985. Violent delinquency cases, defined as homicide, assault, sex offenses, robbery, menacing, and harassment, increased 4.9% over 1994. Drug violations escalated from 1,385 in 1994 to 2,298 in 1995, a 66% increase. Property cases (arson, burglary, receiving stolen property, theft, trespassing and vandalism), public order cases (disorderly conduct, liquor violations, weapons offenses, and other delinquencies), and unruly cases (incorrigibility, truancy, and curfew) all declined in 1995 from 1994, by 3%, 9%, and 3%, respectively. Abuse, neglect and dependency cases climbed from 3,438 in 1994 to 3,576 in 1995, a growth of 4%.

In December 1994, the Cuyahoga County Commissioners requested all County agencies to reduce their 1995 budgets by 11% due to a County budget crisis. The Court complied with the request without laying off any employees or impairing service to clients. To improve efficiency and cut costs, the Court reorganized, reducing the number of departments from seven to four, and relocating many services.

On January 1, 1995, a new statewide initiative, **RECLAIM OHIO**, was put into effect. It is specifically designed to reduce the population in state operated juvenile correctional facilities. Based on a formula calculated by the Ohio Department of Youth Services (ODYS), each county receives an annual grant from ODYS based on the number of felonies adjudicated by its juvenile court. This grant may be used to pay for children committed to ODYS and/or to develop alternative programming. Each county is charged per day for each child committed by that county, in ODYS institutions, except children occupying free public safety beds. Public safety beds in 1995 were used for ODYS commitments where the delinquency adjudication was for murder, aggravated murder, or aggravated rape.

Complying with **RECLAIM OHIO**, the Cuyahoga County Juvenile Court developed a range of alternative services. The target populations for these programs are children committed to ODYS and children in

ODYS institutions considered appropriate for an early release. Programs utilized in 1995 include: Boot Camp, an intermediate sanction for male felony offenders that provides a ninety-day residential boot camp and blends a military and social service approach with an eight month intensive, community-based aftercare program; Community Corrections, a community-based, day treatment model program for male felony offenders providing after school, evening and weekend services; Female Offender Program, a community-based, comprehensive program for delinquent females which provides a variety of services for offenders and their families; Wraparound, an intervention developed by an interdisciplinary team to identify service areas unique to the child which builds upon the strengths of the child and family; Chemical Dependency Residential Treatment, a comprehensive substance abuse treatment program. I anticipate that as the number of commitments is reduced through these programs, more funds will be made available for additional programming for Cuyahoga County youth.

Overcrowding continues to plague the current detention facility. In 1995, the average daily population in the Detention Center was 151, an increase of 4% over the 145 average in 1994. Studies have shown the County may expect continued increases in delinquency cases, especially violent cases, thus requiring more residence space. Plans for a new Detention Center continue to move forward. Cuyahoga County is committed to building a new facility and State funds may be available to offset construction costs.

In 1995, the Cleveland Bar Association, under the leadership of its President Robert Weber, announced juvenile justice and particularly Cuyahoga County Juvenile Court as prime initiatives. One of the main objectives was to develop information to explain the Court's mission and operation. To this end the initiative coordinated funding of an informational video entitled "Making Justice Work for Children." The video will be used by the Court's speakers' bureau as staff address various community, school and religious groups interested in the Court and its activities. An informational brochure is also being developed to accompany the video. I believe the video and brochure will explain our mission as a juvenile court.

Another positive development was the opening of the Day Treatment Program. This program is designed to assist juveniles, who have violated the conditions of their court-ordered probation, to remain in the community and work intensively to resolve some of the problems and behaviors that brought them to the Court's attention. To be eligible for the program, juveniles must be between the ages of 12 and 17, be on probation for a felony offense, and have violated the Rules of Probation. Education and counseling services are provided and students must perform community service.

The Custody Mediation Program, another innovative program of 1995, is designed to alleviate some of the burden custody cases have on the Court. By mediating these cases, fewer require formal Court action. Trained mediators are used to mediate the cases. Funding for the program comes from the Cleveland and Gund Foundations through the Cuyahoga County Bar Foundation.

In my first year as Administrative Judge of Cuyahoga County Juvenile Court, I viewed the year's difficulties as challenges and commend the cooperation of the Court's staff and their dedication to the Court, children, and citizens of this County. I applaud the efforts of the Cleveland Bar Association and look forward to its continued work with the Court.

In compliance with Ohio Revised Code Section 2151.18, I submit the 1995 Annual Report of the Cuyahoga County Juvenile Court, which displays the number and kinds of cases, the dispositions, and other data pertaining to the work of the Court.







