PHASE EXPECTATIONS

Phase 1:

- Compliance with treatment provider.
- Educational assignments related to addiction, peer relationships, and life skills.
- Parental attendance at family programs
- Frequent random urine screening.
- Bi-weekly court hearing
- Complete phase one application

Phase 2:

- Continued care & compliance with treatment provider.
- Frequent random urine screening.
- Appear before the Jurist every 3 weeks.
- Regular meetings with Case Manager
- Complete phase 2 application.

Phase 3:

- Continued care & compliance with treatment provider.
- Frequent random urine screens.
- Obtain a job or other vocational activity.
- Appear before a Jurist once a month.

WHO IS ELIGIBLE?

Youth that:

- Reside in Cuyahoga County.
- Are ages 14-17
- Have a demonstrated history of alcohol/drug abuse
- Are at moderate to high risk of reoffending.
- They are charged with a non-violent felony 3,4,5 or misdemeanor offenses.
- No prior ODYS commitments.

- The Drug Court Jurist shall always have the discretion to admit or deny admission into Drug Court in accordance with the written criteria. The legal and clinical description does not create a right by the participant to enter Drug Court.

- If legal criteria is met, an Intake appointment is scheduled with an assigned case manager and information is provided regarding Drug Court requirements and expectations to the participant and his/her parent(s)/guardian.

Use Disorder Assessments

- Clinical Assessments are scheduled at the time of intake if not already provided. The assessments will be completed by a clinician from a court contracted treatment provider.
- The assessment will be utilized to determine if the youth meets the clinical criteria to ensure that the youth is appropriate for Drug Court.
