In order to submit a Transcript/Audio Copy Request Form, you must have one of the following: a filed Notice of Appeal, an order from another court granting you access to a copy of the transcript of the hearing(s) (i.e. Court of Appeals), or an order from this court granting you access. To obtain an order from this court granting you access, you must first file a Motion for Transcript

A. FILING A MOTION FOR TRANSCRIPT

- Please type or <u>neatly</u> print on the Motion for Transcript Form as well as the accompanying Certificate of Service when preparing your documents. <u>Blue</u> ink is preferred for all signatures. Your forms <u>must</u> be fully completed before they can be filed with the Clerk's Office.
- Case number must be placed in the upper right corner. Be sure you have the correct case number. The clerk is not responsible for determining which case number to use.
- YOU MUST SPECIFY EACH HEARING DATE YOU WANT TRANSCRIBED ON THE MOTION FOR TRANSCRIPT.
- A FILING FEE IS REQUIRED AT THE TIME OF FILING AND THE FEE MUST BE PAID AS FOLLOWS: \$25.00 PER CASE NUMBER

THERE ARE FOUR (4) ACCEPTABLE METHODS OF PAYMENTS:

- CASH YOU MUST HAVE THE EXACT AMOUNT
- CHECK MAKE PAYABLE TO JUVENILE COURT
- MONEY ORDER MAKE PAYABLE TO JUVENILE COURT
- CREDIT CARD YOU WILL BE CHARGED A 2.5% CONVENIENCE FEE (NON-REFUNDABLE)
- Await a journal entry in the mail informing you if the motion has been granted. If your motion is granted, you may proceed to "Submitting a Transcript/Audio Request Form".
- B. SUBMITTING A TRANSCRIPT/AUDIO REQUEST FORM
- Please type or <u>neatly</u> print on the Transcript/Audio Copy Request Form. <u>Blue</u> ink is preferred for all signatures. Your forms must be fully completed before they can be filed with the Clerk's Office.
- Please attach one of the following to the Request Form: a filed Notice of Appeal, an order from another court granting you access to a copy of the transcript of the hearing(s) (i.e. Court of Appeals), or an order from this court granting you access (see above).
